## Schedule 1 – Licence conditions of approval

### Food business (fixed) details

Reason for food safety program: Caterer off-site

### **Conditions of approval**

- 1. The licence holder must comply with the *Food Act 2006*.
- 2. The licence holder must display the licence, or a copy of the licence, in a prominent position at the premises so it is easily visible to persons at the premises.
- 3. The licence holder must ensure the licensee's premises under the licence comply with the *Food Standards Code*, standard 3.2.3 (Food premises and equipment).
- 4. The licence holder must ensure the conduct of business at the premises is in compliance with the *Food Standards Code*, standard 3.2.2 (Food safety practices and general requirements).
- 5. The licence holder must allow a Council authorised person to have reasonable access to the premises under the licence during normal business hours for the food business.
- 6. The first compliance audit of this accredited food safety program must be conducted within six months of the issue of the food safety program accreditation.
- 7. Accredited food safety program compliance audits must be conducted at a frequency of at least one during every 12 month period following the first compliance audit. A copy of the accredited food safety program must be kept onsite at each premises from which the business is carried on.

#### **Advice information**

- Approval is granted under the provisions of the stated legislation only, and does not remove the requirement to comply with all other statutory and/or local government requirements.
- An advertising device licence may be required for the installation of an advertising sign. Contact us or visit our website for further information.
- Plumbing and drainage approval may be required for making changes to, or installing plumbing and drainage related infrastructure. For commercial buildings, often a hydraulic services design is required. This may require a private hydraulic consultant to be engaged to produce a design and submit the application to the City of Gold Coast for assessment and approval. All work must be conducted by a licensed plumber. Contact the City Development Branch of the City of Gold Coast or visit our website for further information.
- Approval from a building certifier may be required for the construction and renovation of buildings, including internal fit outs. Contact the Building Services Authority (BSA) for further information regarding building certifiers in your area.
- A trade waste approval may be required if your business operations include the washing of utensils, crockery and cutlery. Contact the Network Reliability Branch of the City of Gold Coast or visit our website for further information.
